

PFEW Detectives' Survey: Changes to the CPS Director's Guidance on Charging

FOREWORD

INTRODUCTION

Due to the recent changes to the CPS Director's Guidance on Charging (applied in January 2021), the PFEW conducted a short survey on behalf of the Police Federation's National Detectives Forum to assess the impact of these changes on Detectives.

This report provides a summary of the results from this survey for Derbyshire Constabulary, and where appropriate, details of results for detectives from previous years.¹ However, differences across these figures have not been tested to assess whether they are statistically significant;² therefore, any and all differences are included for guidance only and must be treated with caution. Please be aware that the total number of responses for each item may vary slightly as not all items were answered by all respondents. As such, results are provided as valid percentages³ and were rounded to the nearest whole number.⁴ In addition, the actual differences between any and all groups may be quite small, and these details should be considered when interpreting the data.

RESPONSE RATES

Survey responses were gathered over two time periods: A four-week period between October and November in 2021, and a five week-period between January and February 2022. All Detectives in England and Wales were eligible to participate.⁵

In total 6,298 responses were received from the 43 forces of England and Wales, analyses were conducted on a sample of 53 responses from Derbyshire Constabulary. Overall, 292 survey respondents declined to indicate the police force within which they work or indicated that they work in another type of location or force category (e.g., they work across more than one force area). These respondents have been included in the results for the full sample (i.e., all respondents to the survey), but are excluded from force level-breakdowns. There is still no accepted measure of the total number of detectives in England and Wales, nor was a local

estimate provided. Therefore, it is not possible to calculate a definitive response rate for the survey as a proportion of the total number of detectives. Despite this, we can be confident that the sample size was large enough that the percentages quoted in this report can be considered to be accurate within the normal bounds of academic rigour.⁶ In addition, the total number of responses was similar to previous PFEW Detectives' Surveys conducted between 2013 and 2015.⁷

Forces with 50 or more responses were also provided with local reports detailing the results for their force areas alone. The 15 force areas that reached this threshold during the four-week period between October and November in 2021 were provided force reports in December 2021.⁸ Within these 15 reports, where comparisons are made between the force's results and those from the 'Full sample,' this refers to the interim national findings which are based on the responses gathered across 26 forces⁹ during this time period via PFEW HQ surveys only (n=3,042: Research Report R126/2021). Cheshire Federation conducted their own version of the survey and subsequently shared the data with PFEW HQ in 2022 for inclusion in the national dataset. Whilst they also received a force report in December 2021, their data did not contribute to the interim national findings.

The 23 force areas that reached the threshold value of 50 responses during the five-week period between January and February 2022, including Derbyshire Constabulary, were provided with force reports in March 2022.¹¹ Where comparison are made between Derbyshire Constabulary's results and those from the 'Final national sample,' this refers to the full national findings which represent all 6,298 responses gathered between October 2021 and February 2022 across the 43 police forces in England and Wales.

EXECUTIVE SUMMARY

- 53 responses were received from Derbyshire Constabulary in total.
- 94% of respondents from Derbyshire Constabulary told us that their **workload is currently 'Too high,' or 'Much too high.'** Moreover, 96% indicated that their **overall workload has increased** due to the recent changes to the CPS Director's Guidance on Charging.
- 77% of respondents from Derbyshire Constabulary reported a **low job satisfaction** rating of 4 or less. In addition, 94% said that their **overall job satisfaction had decreased** due to the recent changes to the CPS Director's Guidance on Charging.
- 81% of respondents from Derbyshire Constabulary characterised their job as 'Very' or 'Extremely' stressful. Moreover, 96% said the recent changes to the CPS Director's Guidance on Charging had **increased how stressful they find their job.**
- 74% of respondents from Derbyshire Constabulary rated their morale as 'Low' or 'Very low.' In addition, 98% said their **morale had decreased** due to the recent changes to the CPS Director's Guidance on Charging.
- 98% of respondents from Derbyshire Constabulary indicated that the changes to the CPS Director's Guidance on Charging had **increased the number of hours spent on pre-charging file preparation,** and 96% said that the changes had **increased the number of hours needed to submit a pre-charge file to the CPS.**
- However, 85% of respondents from Derbyshire Constabulary indicated that the changes to the CPS Director's Guidance on Charging had **decreased the number of hours they were able to spend actively investigating live cases** (due to increased case preparation work), and 94% said that the changes had **decreased** the efficiency of the criminal justice system.
- In addition, 94% of respondents from Derbyshire Constabulary indicated that the changes to the CPS Director's Guidance on Charging had **increased the number of active cases they are working on** and 48% indicated that the number of **victims that have withdrawn from active participation with their investigation has increased** due to these changes.
- Finally, 65% of respondents from Derbyshire Constabulary indicated that the recent changes to the CPS Director's Guidance on Charging had **increased their intention to leave their role as a detective.**

RESULTS

TRAINING

Respondents were asked to indicate the level of detectives training they had completed at the time of the survey, and prior to January 2021 (when the CPS Director's Guidance on Charging had changed). Results for Derbyshire Constabulary can be seen in the table below:

OVERALL WORKLOADS AND JOB SATISFACTION

Overall, 83% of respondents told us that their workload is currently *'Too high,'* or *'Much too high.'* Breakdowns for Derbyshire Constabulary can be seen in Table 3, and a historical comparison can be found in Table 4.

Respondents were asked to rate their overall job satisfaction between 0 and 10, where 0 was *'Not at all satisfied'* and 10 was *'Completely satisfied.'* Overall, 61% of respondents reported a low job satisfaction rating of 4 or less.

Breakdowns for Derbyshire Constabulary can be seen in Table 5, alongside a historical comparison.

STRESS AND MORALE

Work related stress was measured using a single-item measure. Overall, 59% of respondents said that they viewed their job as 'Very' or 'Extremely' stressful.

Breakdowns for Derbyshire Constabulary can be seen in Table 6, alongside a historical comparison.

Respondents were also asked to rate their morale on a five-point scale from 'Very low' to 'Very high.' Overall, 55% of the full sample rated their morale as 'Low' or 'Very low.' Breakdowns for Derbyshire Constabulary can be seen in Table 7, alongside a historical comparison.

IMPACT OF CPS GUIDANCE: OFFICER IMPACTS

Respondents were asked to indicate how the recent changes to the CPS Director's Guidance on Charging had affected their workload, their morale, how stressful they find their job, and their overall job satisfaction as a detective investigating serious and complex crime.

Results for Derbyshire Constabulary are below in Table 8.

To identify whether the same pattern of results were evident specifically for complex and serious crime, the analyses was re-run only using responses from Derbyshire Constabulary Detectives that had indicated being PIP 2 trained (and had been PIP 2 trained prior to January 2021; n=34). The results are below in Table 9.

IMPACT OF CPS GUIDANCE: OPERATIONAL IMPACTS

Respondents were asked to indicate how the recent changes to the CPS Director's Guidance on Charging had affected a range of job-related outcomes for serious and complex crime.

Results for Derbyshire Constabulary are below in Table 10.

To identify whether the same pattern of results were evident specifically for complex and serious crime, the analyses was re-run only using responses from Derbyshire Constabulary Detectives that had indicated being PIP 2 trained (and had been PIP 2 trained prior to January 2021; n=34).

INTENTION TO LEAVE

Respondents were asked about their intentions to remain or leave in their current position, and to indicate how the recent changes to the CPS Director's Guidance on Charging had affected how they felt about their job.

Overall, 23% of respondents from Derbyshire Constabulary indicated that they would like to remain a detective in their current role and force (please see Table 12 below), and 65% respondents from Derbyshire Constabulary indicated that the recent changes to the CPS Director's Guidance on Charging had increased their intention to leave their role as a detective (please see Table 13).
