Best Doctors can be used for a wide range of medical conditions, from serious illnesses such as cancer and heart disease to less critical conditions such as back pain, severe migraines, skin conditions or diseases of the eye:

**Diseases of the nervous system:** Such as Alzheimer's and Parkinson's, multiple sclerosis, epilepsy, severe migraines.

Diseases of the ear: Such as hearing loss, otosclerosis, vertigo.

Respiratory system conditions: Such as asthma, sleep apnoea.

Musculoskeletal conditions: Such as persistent back pain, arthritis, scoliosis

**Gynaecological conditions:** Such as endometriosis, painful/irregular periods, ovarian cysts.

Circulatory system: Such as hypertension, heart attack and stroke.

**Skin diseases:** Such as psoriasis, allergies, chronic urticaria (hives), atopic dermatitis, vitiligo.

**Diseases of the eye:** Such as cataracts, retinal disorders, glaucoma and macular degeneration.

**Metabolic and endocrine:** Such as diabetes, thyroid diseases or growth disorders.

**Digestive disorders:** Such as gastric disorders, inflammatory bowel disease, liver disorders.

Urological conditions: Such as renal failure, cystitis.

Cancer: Such as tumours, leukaemia, Hodgkin's lymphoma.

Immunological diseases: Such as HIV/AIDS, sarcoidosis, food allergies.

**Blood diseases:** Such as haemorrhagic conditions, refractory anaemia, myeloma.
