Definition of Driving

Whilst there's no legal definition, 'driving' is generally held to mean 'being in control of both the direction and the propulsion of the vehicle'.

Note: the driver is still 'driving' even when stationary, with the handbrake on, in a queue of traffic, such as waiting at red ATS.




Note the Batch No., normally indicated by four digits such as: 4217 indicating Week 42 of 2017.



Sidewalls must be free from cuts or bulges that will affect the strength or integrity of the tyre when under load.

Bulges bulge outwards. A slight inversion, where the rubber is joined, is normal and acceptable.

Consider heavily marking the outside of an illegal tyre with yellow road chalk or paint in order to make it conspicuous.
