# North Wales Group Insurance Trust Annual Report Members Update

1st March 2024 – 28th February 2025

#### Scheme Update

In the past year £111,094.45 has been directly paid to members and the beneficiaries of the North Wales Group Insurance Trust through the various scheme benefits.

The scheme has also assisted **673** members and their families through the provision of Travel, Motor Breakdown, Home Emergency, GP24, Mobile Phone, Health Assured and the Legal Expenses Service.

#### **Scheme Changes**

During the past year we have met with our scheme managers from Philip Williams & Co on a quarterly basis to review the scheme performance and claim's history.

At the renewal meeting in January the following benefits were due for renewal:

- Travel
- Vehicle Breakdown
- Home Emergency
- GP24
- Health Assured

Some areas of cover have seen increasing costs and inflationary pressures, for example operating costs associated with Vehicle Breakdown and Home Emergency. As a result of these overall pressures a small increase to overall subscription cost was necessary.

#### **Monthly Subscriptions**

The new monthly subscriptions for 2025 - 2026 are as follows.

Although a small increase was needed it has also been possible to enhance some benefits as described below:

#### **Legal Expenses**

- The legal expenses provider has changed to Temple-Legal Protection and the number to contact them for assistance is 01483 954 089.
- Disciplinary Hearings (Misconduct) Limit has increased to £25,000.

#### **Travel Policy**

- The policy now includes full cruise cover.
- For those retired members over 70 years travel cover has been extended to age 80 with limits to European travel for those aged over 75.

#### **Health Assured**

 Health Assured now offer a service to include Financial Coaching, provided by Munny.

#### **GP24**

 New GP24 App and Digital Booking System allows you to choose an appointment time to suit your needs.

#### The next renewal of the scheme will be in March 2026.
