

Asbestos Exposure Questionnaire

The Police Federation is currently undertaking a process to determine asbestos exposure amongst members. The risk of asbestos exposure arises from the presence of asbestos in many UK workplaces, including Police Stations, premises used for training purposes and detention centres, particularly when it becomes damaged due to refurbishment work or poor maintenance. Some members may have come into contact with asbestos in other employments before joining the Police service.

The purpose of this questionnaire is to collect information on past employment where there may have been exposure to asbestos in order to create a structured and permanent database of information and factual records. Therefore, it is important that if you know or suspect that you have been exposed to asbestos in the past, you should please complete this form and return it to the address located at the end of the Questionnaire.

It is important to remember that not everyone who has been exposed to asbestos develops an asbestos related disease. However, for those who do develop disease, the effects can be devastating. By collecting information now on past employment for all members who know or suspect that they may have been exposed to asbestos, the Police Federation aims to assist any future claims for compensation for members who develop asbestos related illness. The information you provide is for your protection as well as possibly benefiting other members.
